

Uuestion:	Please comment on those aspects of the course (activities, materials, etc.) that you found MOST valuable.
Response Rate:	88.89% (8 of 9)

There are three main aspects that I find most valuable in the course. First, the illustration of ethical dilemmas through the use of cases. This allows me to practice the ethical standards I learned in theory. Additionally, it puts me on the spot and allows me to exercise my ability to make a decision. Second, the use of class discussions to further explore and dissect the readings. When we read for class, sometimes some professors don't even address them when we attend class or they merely restate what we read. But in this course, the professor encourages us to deeply explore and critically think about what we read that week. Finally, and most importantly, I truly believe one of the most valuable part of the course is the cold calling. You know you could be called on at any time, in which you have to show an astute understanding of the readings, but you don't have to do an assignment for every class.

- The use of case examples and integration of real world application with theories and literature. The course provided an opportunity to bring to class potential issues and concerns that might arise.
- The instructor was extremely knowledgable and helpful in providing insight and sharing his experiences to help us understand the applied aspects of ethics.
- The instructor has a knack for grounding often complex, highly subjective and deeply personal constructs of values, ethics and guiding principles to real-time, genuine scenarios that one is likely to confront dilemmas and often, lack of knowledge of the "right versus wrong" mechanisms of decision making. Such teaching is extremely thought-provoking, grounding and in its didactic style of encouraging discussions on difficult dilemmas, yet within a safe setting; this is a unique course with both, valuable skills and perspectives.

Presentation of clinical cases and class debates were a great way to demonstrate the range of perspectives and

6	I enjoyed our class discussions every week on the assigned readings. It was nice to feel like the reading would be discussed in class and that its sole purpose was not only outside learning. I thought the in class case discussions were great learning material. This allowed students to apply their knowledge to a clinical case and discuss potential outcomes. All assignments were great learning experiences - the EDMA especially helped me to apply the knowledge from the class and reflect on how I would incorporate it into my own practice.

- 2 The only aspect of the course that I do not like is the fact that the homeworks are due the day of class.
- Sometimes, there appears to be a dis-balance between personalized tasks/assignments (such as self-care plans, EDMA) and learning about ethics, laws and policies. I am concerned that this course might be the only opportunity for me to learn along with a very approachable instructor (Shamir), to be able to learn along the policies and guidelines at least of the New York State, that govern clinical practice. A balanced focus on this latter component would be integral to the many other vital concepts that we are learning in Shamir's coursework.
- Some students would spend too much time giving their two cents during discussions, which delayed the process and was sometimes not very helpful nor relevant.
- Perhaps less iterations of assignments; condensing readings/sessions into maybe 4-5 classes and have us go through clinical cases, ethical dilemmas for the rest of the time. Course felt prolonged at times.
- I feel that although this was a great place to discuss cohort concerns and other matters slightly less class time could be devoted to this topic. 20 minutes at most would probably suffice. I think this information is extremely valuable, however sometimes I felt it cut into learning the class material.
- 7 Class readings were sometimes redundant.

Question:	In what ways was the instructor MOST effective? Please give examples.
Response Rate:	88.89% (8 of 9)

- The professor is most effective in his ability to provide his students with a well-rounded, critical, and in-depth understanding of the course. Through class discussions, the knowledge we gain through the readings is further solidified in class. In addition, he has an extremely engaging teaching style. Finally, his honesty is by far the best thing about him as an instructor.
- The instructor is very involved in making sure that we're getting the most out of the course, making himself very available for consultation, even outside of office hours. He also shared a lot from his personal experiences from his career.
  - Shamir was EXCELLENT by far one of the most organized and dedicated professors I have had at TC. First, time

management was a great skill he taught us - insisting that everyone arrive on time. He discussed the reading in class which was an extremely effective way of motivating everyone to do the reading. He did 1-2 clinical cases per class which was an effective way of applying the information that was discussed throughout the course. He also brought in a guest speaker to discuss legal concerns when working in mental health. This was another effective way for the students to both learn and absorb the material and also find the clinical relevance of the subject matter. Shamir was effective in addressing the needs of our cohort and helping us navigate the program. It was nice to have a space to discuss matters that were important to us. Shamir has a non-judgmental, directive, and respectful manner of challenging presumptions, guiding through the complex case scenarios, being respectful in providing feedback and overall creating a space of didactic and cohesive dialogue and discussion in the classroom context. Such traits in him also help bring about a sentiment of empathy towards others' perspectives, being able to nurture ambiguity (not all answers are or will be known), and develop a functional level of cohesion and trust within the cohort. I am grateful to Shamir for creating such a space, bereft of differentials and ripe with democratic and fair/equitable thought and perspective sharing. Organization of materials, clarity of his expectations of us in terms of readings, discussions, and assignments, 5 providing feedback and insight during discussions, and time management. Facilitating class discussions, helpful advice. Dr. Khan was able to use his own case illustrations to engage us in critical ethical thinking. This helped the material 7 sink in deeper. - Creating a classroom environment that allows for exploration of complex themes - Providing constructive feedback on assignments - Always tying the lessons and dilemmas in class to real world scenarios and applications

- I often wish the tone was more encouraging rather than anxiety provoking. I also felt that the constant reminders that we were being evaluated was very unhelpful to already existing anxieties amongst the class. The "group process session" was poorly initiated and facilitated, causing a palpable but unspoken rift/ anxiety amongst the cohort.
- He's extremely understanding and accommodating, but maybe sometimes he could try more to stop someone from talking for too long during discussions, especially when their points are not very relevant to the topic of discussion? I understand this is very difficult to maneuver, so it is just a minor thought.
- Often we ran out of time to discuss topics that should have been covered
